

What Did They Say?

This summer, I have heard more comments than usual about what "they" said at the General Assembly this summer...not all of which have been completely accurate. So, I thought it might be helpful to share some of the things that were done.

One thing that might be most helpful is to clarify just who the "they" are. First, what the General Assembly is NOT. It is not national staff. It is not a group of 'experts' gathered or hired to tell us what's what. The General Assembly is made of folk just like us. In fact, it is us! Every other year each presbytery elects some of their church members and pastors to join with similar folk from across the country to discuss, debate, and discern how the Holy Spirit is leading our church on a variety of issues.

How are these folk selected? In Homestead, our Nominating Committee solicits members in churches to express their interest to be our commissioners. This past summer we sent two pastors and two ruling elders who were voted by the churches' representatives at a presbytery assembly.

SOMETHING ELSE...ABORTION. Many have misunderstood our General Assembly commissioners' statements on abortion. Our commissioners have issued several statements. Here is some of what has been said:

This Assembly regards the destruction by parents of their own offspring before birth, with abhorrence, as a crime against God and against nature. (GA, 1869)

The fetus is a human life to be protected by the criminal law from the moment when the ovum is fertilized. (GA 1965)

Women should have full freedom of personal choice concerning the completion or termination of their pregnancies. (GA 1970)

The strong Christian presumption is that since all life is precious to God, we are to preserve and protect it. Abortion ought to be an option of last resort.

Abortion is not morally acceptable for gender selection to obtain fetal parts or transplantation.

We affirm that abortion should not be used as a method of birth control.

HOMOSEXUAL ISSUES. The General Assembly commissioners took a couple of actions:

- 1. If the state law allows same-sex marriages, the commissioners said that a pastor would not be prohibited from officiating at such ceremonies. Note: No pastor can be required to marry anyone. No session can be required to permit marriage ceremonies of anyone in their church. It was recognized that same-sex couples are active members in many churches, and if a pastor is asked by a member to perform a marriage, the response should first be pastoral toward the congregation's members.
- 2. Asked presbyteries whether our Book of Order should be changed to read:

"Marriage is a gift God has given to all humankind for the well-being of the entire human family. Marriage involves a unique commitment between two people, traditionally a man and a woman, to love and support each other for the rest of their lives. The sacrificial love that unites
