


### Get Lost in a Book

### Response Team forms after 2019 Floods

This scripture verse is one we have quoted often to those dealing directly or indirectly with the aftermath of melting snow, rain and flash floods since mid-March in Homestead Presbytery. God's Word continues: "Therefore we will not fear, though the earth should change, though the mountains shake in the heart of the sea; though its waters roar and foam, though the mountains tremble with its tumult... the Lord of hosts is with us." Presbyterian Disaster Assistance (PDA) has sent an initial assessment team to Homestead

Presbytery and a Presbytery Disaster Response Team is being formed to oversee the ongoing clean-up and repair that will be needed for many months to come.

Many within the Presbytery have already responded with clean-up buckets, personal hygiene kits, physical labor and initial acts of kindness and contributions – all of which are appreciated and needed. And we thank you for being Christ's hands and feet here on earth!

Site visits are currently happening to continue to assess needs and offer emotional, spiritual and mental support to those "on the ground and living in and through the midst of disaster"; plans are being formulated to establish work camps/sites, and the initial grant to Homestead Presbytery has been submitted to PDA.

Here are things that YOU (and those you know and love) can do right now:

- 1. **Pray** (and pray again after all, the power of prayer is in the One we pray to --- NOT in those of us praying)
- 2. **Contribute financially** as you are able:
- \*to PDA (#DR000191)
- \*to Homestead Presbytery (for disaster relief)
- 3. **Help**
- \*provide geographically-wise housing/meals sites for work groups helping in the disaster areas in coming months
- \*make arrangements to work days/weeks (when such needs are clearly known) individual and as groups
- \*volunteer for various sub-committees within the Homestead Presbytery Disaster Relief group being formed

## Housing allowance decision elicits cheers, and relief

The Board of Pensions received word during its Board of Directors meeting

last month, prompting muffled cheers and widespread relief. The clergy housing allowance had been ruled constitutional.

On March 15, 2019, in Gaylor v. Mnuchin, a three-judge panel of the 7th U.S. Circuit Court of Appeals unanimously ruled that excluding a housing allowance from a minister's taxable income does not violate the establishment clause of the First Amendment.

The decision overturned a 2017 federal district court ruling that Section 107(2) of the Internal Revenue Code, which provides the exclusion, is unconstitutional because it was a unique benefit for ministers. The appellate court disagreed, finding that section 107(2) has a secular purpose, putting ministers on an equal footing with certain secular employees receiving employer-provided housing. Section 107(1), the exclusion for tax-free in-kind housing, such as a manse, was not at issue in the case. Read More Here
