## **Notes from the Commission on Ministry:**

\*minimum salary for Homestead Presbytery for 2021 is \$48, 960. (Homestead Presbytery policy is that minimum salary is to be 80% of the median effective salary as established by the Board of Pensions which is \$61, 200 for 2021, making the minimum \$48,960 for us.)

\*be watching for more information on Boundary Training in early January, 2021 of The Homesteader. This will be an on-line event and COM has determined that we will use the material presented and developed by the Presbytery's insurance company - Praesidium - in a program called Armatus Learn to Protect System. There are 14 units to this 3 year program - the first six will be designated by COM and COM expects everyone to complete those six in the first year.

# Clarkson New Zion upgrades their online worship with Homestead's Technology Grant



Hello Homestead Presbytery,

My name is Casey Sayers and I am a session member for New Zion Presbyterian Church in Clarkson, NE. I was also a part of the temporary committee we formed in order to handle the technology grant offered by the presbytery. The committee met several times in person and communicated through a group chat in order to communicate ideas on how the tech grant could benefit our church. With 2020 being such a difficult year for churches to meet and to share the word

of God in person, our committee decided that the best thing we could do for our congregation would be to make our worship services available online. When we first started offering online worship service, we used a webcam on an aging laptop in an

effort to stay connected with our congregation. On an average week we had 5-10 members that watched live, and some weeks had as many as 75 views after posting to Facebook. After dealing with poor quality of sound and picture for a few months, I offered my personal webcam from my desktop computer in an effort to improve quality. However, there was little improvement and after a few weeks of use the camera failed and did not work for the services anymore. This was when we knew what had to be done. We did some research and price checking and found that we could replace the obsolete laptop with a new one and purchase a higher-grade camera for around \$1,300. A family in our congregation generously offered to cover whatever the total was above the \$1,000 of the grant. We watched prices of both the camera and laptop for a couple of months to save as much money as possible and finally on Cyber Monday we found a high spec laptop for \$300 off its normal price and made a purchase.

The camera was ordered a week or so later. After some trial and error learning the new systems, we were able to use the camera for our Christmas Eve candlelight service. The response from our congregation was one of



excitement and anticipation. Those who join us regularly were happy with the improved video quality and clarity. We're still working out a few kinks with the audio pickup for the live stream video, but we will get better as we get more familiar with the software and the devices themselves. We are looking forward to the opportunities that this new technology has presented us as we do our best to provide healing, guidance, and love for all during these trying times. On behalf of New Zion Presbyterian Church, I would like to thank you for this opportunity and for your consideration for this technology grant. Attached are pictures of the laptop and camera in use during worship along with the receipts from the online purchases. As you can see the purchases were made from my personal account and shipped to my address. This was because the church did not have a means of making an online purchase and we were running out of time to get a credit card for church related online purchases.

# Homestead Wednesday Zoom Forums


